Note: The State-By-State Adoption Law Chart is based on information I complied from attorneys who are expert in state adoption law. (I was unable to obtain updated information from Montana and Rhode Island, so those states are not included on the chart.) I am not an attorney myself; thus, there could be some errors of interpretation. It's also true that state laws change, so do not assume the laws described on this chart are etched in granite for all time. They aren't. Instead, use the chart as a guide only, and consult with your adoption arranger on the current laws as of the time that you adopt.
